OUR WORK

This was the final year of the 2015-2018 Strategic Plan.

Our main focus was to increase partners' awareness, knowledge, and understanding of relevant agri-environmental issues. Building relationships was a key step in the process.

We saw issues related to land-use and water, with an increased focus on climate change, returning as primary issues this year. In conjunction with the next step in the Government of Alberta's (GOA's) Climate Leadership Plan (CLP), the Advisory Committee tasked the Land-use Framework (LUF) Working Group with developing an approach AEPA could use to further address the topic.

This included Advisory Committee engagement with CEOs of public agencies who invest funds associated with the CLP, including Emissions Reduction Alberta, Alberta Innovates, and Energy Efficiency Alberta.

The Water Working Group prioritized building awareness and understanding of on-farm surface water management, including how to balance environmental sustainability with economic viability. An initial strategy was developed with the intent to identify and recommend options on how best to address these challenges from a policy perspective.

Throughout the year AEPA contributed to policy and program development for the new *Canadian Agricultural Partnership (CAP). CAP* is a successor to Growing Forward 2 and comes into effect April 1, 2018. We were able to work with our partners to provide both general agriculture and organization-specific feedback.

The Advisory Committee also spoke directly with senior GOA staff, including AF Deputy Minister Bev Yee, about policy of relevance to AEPA.

A tour was organized for our partners including the Farm Stewardship Centre in Lethbridge and Lethbridge BioGas. This tour was an opportunity to learn about sustainability initiatives on the ground.

The 2018-2021 Strategic Plan was developed and approved, providing AEPA direction for the next three years.

This was also the final year of the three year term for the Industry Co-Chair. We would like to thank Martin Van Diemen for his leadership, dedication, and contribution in helping AEPA move forward on Strategic Priorities.

LOOKING FORWARD TO 2018-2019

Entering into the first year of our new three year plan we will continue to focus on land-use, water, and climate change.

We will continue to increase awareness, knowledge, and understanding of issues, as well as seek opportunities to provide input into policy development processes. We will also continue to increase engagement and build relationships with policy decision makers and influencers.

The LUF Working Group will continue to gain a better understanding of climate change and its potential impact on agriculture. They will work on the topics of adaptation and the carbon offset market, and contribute input when opportunities arise.

The Water Working Group will move forward with the strategy to help address challenges related to on-farm surface water management, including developing options to address issues through policy input.

Both Working Groups will review the draft North Saskatchewan Regional Plan (NSRP) when released and recommend feedback to the Advisory Committee for consensus input.

We welcome the new Industry Co-Chair, Don Shepert, who steps into the role on April 1, 2018.
